

EDX Errors & Warnings List

DEFINITIONS:

Error: An issue that <u>must</u> be resolved before you can move to the next step in the collection process.

Warning: An issue that should be reviewed, but <u>**not**</u> one that will prevent you from moving to the next step in the collection process.

Warning types:

- **Funding:** Warnings that will have a funding impact.
- Information: Warnings for records that appear to contain atypical data but won't impact funding.

HOW TO USE THIS DOCUMENT:

Search by the error message or warning message that you are receiving to find the appropriate action for resolving the message.

Included in the Warnings section are the funding consequences for each Funding Warning, as well as a column that indicates which warnings were previously classified as errors.
